**MINUTES OF THE**

**LINCOLN COUNTY BOARD OF COMMISSIONERS**

**MEETING OF NOVEMBER 22, 2006**

**CALL TO ORDER**

Chair Don Lindly convened the adjourned session of the Lincoln County Board of Commissioners meeting at Siletz City Hall after the joint session with the Mayor and City Council of the City of Siletz. Present at the meeting were Commissioner Bill Hall, Commissioner Terry Thompson, Assistant County Counsel Rob Bovett, and County Counsel Wayne Belmont.

**ROLL CALL - ESTABLISHMENT OF A QUORUM**

**RECOGNITION/PROCLAMATION**

Assistant County Counsel Rob Bovett presented a report on efforts locally (in Siletz and Lincoln County), across the state and across the nation to combat meth abuse, focusing on gains in the battle and the need to continue be aware of the issues in our communities. He discussed the three prongs of combating the meth problem: prevention, enforcement and treatment. He described the effort in each of those areas in the county.

After discussion of the problem, Commissioner Thompson moved to execute and record Resolution # 06-22-11A proclaiming November 30, 2006 as National Methamphetamine Awareness Day in Lincoln County, and encouraging all citizens of Lincoln County to celebrate recovery and show their strong support for prevention, enforcement, and treatment. Commissioner Hall seconded the motion. The vote was taken and the motion passed unanimously.

**PUBLIC HEARING**

**DECISION/ACTION**

Assistant Counsel Bovett described the election results for the annexation of certain properties into the North Lincoln Fire District. Voters within the Fire District and within the area to be annexed approved the annexation. Commissioner Hall made a motion to execute and record Order # 11-06-392 annexing certain territory into North Lincoln Fire and Rescue rural fire protection district. The area annexed extends the district from about mile marker 6 up the Siletz River Highway to about mile marker 9 up the Siletz River Highway. Commissioner Thompson seconded the motion. A vote was taken and the motion passed unanimously.

**MOTION TO EXECUTE AND RECORD ORDER # 11-06-392 REGARDING THE ANNEXATION OF CERTAIN TERRITORY INTO THE NORTH LINCOLN FIRE AND RESCUE RURAL FIRE PROTECTION DISTRICT**

Assistant Counsel Bovett presented the election results for the formation of the NE San Marine Special Road District. The measure creating the district passed. Because this passed, the Board needs to also call for the election of the first Board of Directors of the District on May 15, 2007. Commissioner Hall made the motion to execute and record of Order # 11-06-393 forming the NE San Marine Special Road District, and calling for an election of its first board of directors on May 15, 2007. Commissioner Thompson seconded the motion. A vote was taken and the motion passed unanimously.

**MOTION TO EXECUTE AND RECORD OF ORDER # 11-06-393 REGARDING THE FORMATION OF THE SAN MARINE SPECIAL ROAD DISTRICT AND CALLING FOR THE ELECTION OF THE FIRST BOARD OF DIRECTORS FOR THE DISTRICT ON MAY 15, 2007**

Not hearing a request to read the ordinance in full by any of the Commissioners, Chair Lindly read Ordinance # 442 by title only (Ordinance # 442 relating to inventory searches; creating new provisions; repealing LCC 2.075; and declaring an emergency). Assistant Counsel Bovett noted for the record that this ordinance was processed at the request of the district attorney, that counsel's office created this as to the necessary form but did not draft the contents, and that this was an effort to address certain issues the district attorney has concerning inventory searches of persons and vehicles. Commissioner Thompson

made the motion to execute Ordinance # 442 “relating to inventory searches, amending LCC 2.075, and declaring an emergency.” Commissioner Hall seconded the motion. A vote was taken and the motion passed unanimously.
