## **PUBLIC HEARING**

## **DECISION/ACTION**

Chair Hall reminded everyone present that the Board heard a presentation on the proposed County Fee Schedule two weeks ago. Counsel Belmont noted that no comments were received on the proposed changes, but staff had a discussion with the Sheriff on a couple his proposed changes concerning the Animal Shelter. Some of the proposed changes will not be made, and they are reflected in the Board Order. Commissioner Thompson made a motion to execute and record Order # 6-07-627 adopting the 2007-2008 Fee Schedule for departments of Lincoln County. Commissioner Lindly seconded the motion. A vote was taken and the motion passed unanimously. Chair Hall inquired if any of the Board had received any direct comments from constituents, which no one had.

## **DISCUSSION/INFORMATION**

### **Powerpoint presentation overview of the Lincoln/Benton County Coordinated Transportation Plan as required by State and Federal mandate for continued funding of some programs**

Transit Coordinator Cynda Bruce introduced Connie Soper, consultant with Nelson/Nygaard Consulting Associates, who has been assisting Lincoln and Benton Counties with their required Transportation Plan. The Plan needs to be completed by the end of June 2007, and is a coordinated plan between counties. Ms. Soper discussed key findings and highlights of the plan, including: goals of the plan; sources of funds; how the funds are distributed; difference between funds and how Lincoln County qualifies for them; funds associated with senior and disabled needs; and the Job Access and Reverse Commute (JARC) plan. Commissioner Lindly inquired about the demographic statistics in the plan for Benton County, which shows a high poverty rate with a conversely low unemployment rate. Ms. Bruce explained that a large portion of the population in Corvallis is made up of students. Ms. Bruce clarified which plans Lincoln County specifically receives funds from, and which ones it qualifies for. Ms. Soper discussed project methodology; population characteristics; stakeholder interviews; and showed maps of key destinations. She discussed unmet transportation needs and strategies to address them; ways to improve services of fixed route transit; and employment-related transportation. The commissioners expressed concern over the numbers representing wages and poverty rates between the two counties, and requested that the numbers be double-checked. Commissioner Lindly discussed the possibility of a future rideshare program between Lincoln and Benton Counties. The commissioners thanked Ms. Bruce and Ms. Soper for the presentation.

## **Commissioners' Reports**

Commissioner Thompson commented on the wave energy forum at Newport High School. Commissioner Lindly discussed the legislative session, which might end today. Commissioner Thompson thanked Assistant County Counsel Rob Bovett for his efforts with meth legislation and wave energy. Chair Hall spent the last two days in Hood River for a meeting of the Governor's Council on Alcohol and Drug Programs, where he was elected Vice-Chair of the Council. \$10 million in general fund money was added to the budget statewide for drug and alcohol programs. Commissioner Thompson reported that Lincoln County was awarded \$80,000 of the \$100,000 available for Regional Investment projects.

All County offices will be closed for the Independence Day holiday on July 4. The next Board of Commissioners meeting will be on Thursday, July 12 in Waldport at 1:30, with a Joint Session to follow at 2:00.

Chair Hall mentioned the joint session with the Tillamook Board of Commissioners on July 2 at 10:30 a.m. The boards will discuss marine reserves, wave energy and other topics of interest.
