Important Information: Licensed facility fees are due each year on December 31st by 5 pm

Licenses are non-transferable from one owner to another.

**Pro-rated fee for new facilities or change of owner
from October 1st to December 31st is 50% of the annual fee.**

Delinquent Payments: For food licenses, late payment penalty fees of \$100.00 are assessed every month, on the first day of the month starting in January, until the facility is closed, or the license is paid.

Pool and Spa fees delinquent 15 days after due are assessed \$100 fee and shall increase by \$100 on the first day of each succeeding month of delinquency.

Traveler's Accommodations delinquent 15 days past the expiration date assess a penalty fee of 50% of the annual license fee. The penalty fee shall be increased by **50% of the license fee** on the first day of each succeeding month of delinquency.
