Effective July 1, 2026

Licensed facility fees are **due each year** on or before December 31 by 5pm
Licenses are non-transferable from one owner to another

Delinquent Payments – Licenses expire annually on December 31 [ORS 624.020(2)]. If payment for the following years license is not made on or before December 31, the following reinstatement fees apply:

Food Licenses: A fee of \$100 is added on the first day of every month beginning in January. This continues each month until the license and fees are paid in full, or the facility is closed.

Pool and Spa Licenses: If payment is more than 15 days late, a \$100 fee is charged. Another \$100 is added on the first day of each following month until payment is made.

Traveler’s Accommodations: If the renewal is more than 15 days late, the penalty is 50% of the annual license fee. Another 50% of the annual fee is added on the first day of each additional month the payment remains late.
