IT IS HEREBY ORDERED THAT:


(1) The Board approves of the annexation of the property described in the petition into the North Lincoln Fire and Rescue District No. 1, and the property is hereby annexed into that district.





DEED ADJUSTING BOUNDARY LINES AND CREATING EASEMENT

KNOW ALL PERSONS BY THESE PRESENTS, that WHEREAS TASHA MACK has by virtue of an instrument recorded on Feb. 13, 2015 as Doc. 2015-01318, Film Records of Lincoln County, Oregon, acquired a record interest in the real property described therein (and commonly known as Map 08-11-02-B0-00502) situated in Lincoln County, Oregon; and

WHEREAS ERICA DUKE has by virtue of an instrument recorded on Feb. 13, 2015 as Doc. 2015-01319, Film Records of Lincoln County, Oregon, acquired a record interest in the real property described therein (and commonly known as Map 08-11-02-00-00300) situated in Lincoln County, Oregon; and

WHEREAS TARA HURLEY has by virtue of an instrument recorded on Feb. 13, 2015 as Doc. 2015-01321, Film Records of Lincoln County, Oregon, acquired a record interest in the real property described therein (and commonly known as Map 08-11-02-00-00500) situated in Lincoln County, Oregon; and

WHEREAS the boundaries between said properties should be adjusted for the convenience of the parties hereto, who are by this instrument intentionally and with full knowledge and intent modifying the boundaries which has heretofore existed, by this exchange of parcels of property, which the parties agree are of equal value, and

WHEREAS the parties have agreed to cause a Lincoln County Survey to be prepared and filed, and applications for property line adjustments to be filed with the Department of Planning and Development of Lincoln County as Case File #04-PLA17 and Case File #05-PLA-17, and having walked the property to be exchanged with the surveyor and approved the adjustment:

NOW, THEREFORE, the parties agree that the common lines between said properties shall be adjusted to conform to the parcels hereinafter described, and the parties, each GRANTORS, do each grant and convey to the other that property along the new agreed common lines as is necessary to create three parcels described in the Exhibits attached hereto and by this reference incorporated herein:

Exhibit 1 entitled: Legal Description Prepared for Tasha Mack/Proposed Tax Lot 502 After Adjustment

Exhibit 2 entitled: Legal Description Prepared for Erica Duke/Proposed Tax Lot 300 After Adjustment

HAVING SO CONVEYED properties between the parties hereto, each does acknowledge and agree that an easement granting rights of access and provision for utilities and services benefitting each property is reasonable and necessary to their use, and the three parties hereto, **TASHA MACK, ERICA DUKE and TARA HURLEY**, GRANTORS, do hereby grant and convey to each other an easement within and upon that certain property described in the attached and incorporated Exhibit 4:

Exhibit 4 entitled: Legal Description Prepared For Tara Hurley, Tasha Mack and Erica Duke/Proposed Centerline Of 50 Foot Private Ingress, Egress, And Utilities Easement Road

GRANTORS acknowledge that each of the properties described in Exhibits 1, 2 and 3 herein benefit from the easement, constituting good and valuable consideration to each party as Grantee, the receipt of which is hereby acknowledged.

THE PURPOSES OF THE EASEMENT are as follows:

There shall be the right in Grantees, and Grantees' invitees, of ingress and egress upon the property subject to this grant of easement. Such access shall be for all those purposes typical of a residential street.

There shall be the right of access by Grantees, Grantees' invitees, and all public and private utility providers working at the direction or benefit of one or more Grantees, and all workers and equipment necessary thereto, to construct, operate, maintain and repair lines of transmission of utility service including the structures and conduits necessary thereto; this grant of easement includes but is not necessarily limited to the provision of water, sewer, waste and storm water disposal, gas, cable and electric services. Such right shall be equivalent to that of a residential street typical for such ingress and egress.

The easement described above is effective immediately upon signature by Grantors and shall continue in perpetuity always subject to the following conditions:

The Grantees and Grantees' successors, holders of the beneficial interests in the easement, shall maintain the easement in good repair.

Except as may be modified by the parties in writing signed by each of them, the obligations for maintenance of the easement shall be shared by each holder of an interest in the easement in the manner and in the proportions as set forth in Oregon Revised Statutes 105.170 through 105.185.

The Grantors and the holders of the easement interests may agree upon detailed maintenance provisions if such agreement is in writing and signed by each of them, such written provisions shall be effective whether or not recorded in Lincoln County Records and binding upon all who have actual notice of them. The written agreement shall cease to be binding upon Grantor or any interest holder who withdraws from the agreement in writing served upon all others to the agreement, unless the agreement specifies a particular term or explicitly states that it is to run with the land in perpetuity and is filed in Lincoln County property records.

This easement and any written maintenance instructions shall, in the event of dispute or non-compliance, be subject to arbitration in accordance with Oregon Revised Statutes 36.300 et

seq. in addition to the right of Grantors or interest holders to sue for money damages, contribution and/or specific performance if Grantors or an interest holder fails after demand to pay proportionate costs or otherwise comply with the terms of this easement. In the event Grantors or an interest holder are required to retain an attorney to enforce the provisions of this easement or written maintenance instructions, the attorney fees and court costs of the prevailing party shall be paid by the party in opposition to the prevailing party.

BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON TRANSFERRING FEE TITLE SHOULD INQUIRE ABOUT THE PERSON'S RIGHTS, IF ANY, UNDER ORS 195.300, 195.301 AND 195.305 TO 195.336 AND SECTIONS 5 TO 11, CHAPTER 424, OREGON LAWS 2007, SECTIONS 2 TO 9 AND 17, CHAPTER 855, OREGON LAWS 2009, AND SECTIONS 2 TO 7, CHAPTER 8, OREGON LAWS 2010. THIS INSTRUMENT DOES NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS.
