10 **WHEREAS** the current assignment of Lincoln County Ambulance Service Area
11 (ASA) 5 to South Lincoln Ambulance Association is set to expire on June 30, 2022; and

12 **WHEREAS** notice of that expiration was duly issued in accordance with LCC
13 7.827; and

14 **WHEREAS** notice was issued to all entities and persons on the ASA mailing list,
15 including, but not limited to, all current ASA holders, all entities previously expressing a
16 desire to possibly competitively apply for assignment of a Lincoln County ASA, and all
17 members of the Lincoln County Ambulance Service Review Committee;

18 **WHEREAS** the only applicant for assignment of that ASA for the period of July 1,
19 2022 through June 30, 2027 is he current service provider, namely South Lincoln
20 Ambulance Association; and

21 **WHEREAS** the Board conducted proceedings in this matter pursuant to the Lincoln
22 County Ambulance Service Area Plan, and applicable provisions of state law, state
23 regulations, and LCC Chapter 7; and

24 **WHEREAS** the Board has carefully reviewed the application submitted by South
25 Lincoln Ambulance Association; and,

1 WHEREAS the Board has also carefully considered:

2 (1) The level of care and quality of service proposed to be maintained by the
3 applicant, and has determined that it will be at a level equal to or greater than the level of
4 care and service previously provided;

5 (2) The contents of the application, and has determined that it meets the application
6 requirements set forth in LCC 7.827(5);

7 (3) The requirements of applicable state law and state regulation relating to the
8 provision of ambulance service, including, but not limited to ORS Chapter 682 and OAR
9 Chapter 333 Division 260, and has determined the application meets those requirements;

10 (4) The past experience and past quality of service provided by the applicant, and

11 (5) The past quality of service provided by the applicant;

12 (6) The proposed quality of service to be provided by the applicant; and

13 WHEREAS, the Board has unanimously determined that ASA 5 should be assigned
14 to South Lincoln Ambulance Association for the period of July 1, 2022, through June 30,
15 2027; therefore, in accordance with LCC Chapter 7 and the Lincoln County Ambulance
16 Service Area Plan,


17 **IT IS HEREBY ORDERED THAT:**


