

Trauma Coverage®

Trauma Coverage is specialized insurance designed to provide fast, flexible support after a covered traumatic event. It offers financial relief through wage replacement, counseling, and recovery benefits—empowering individuals to focus on healing while reducing the long-term impact of trauma.

Coverage includes every day events such as aggravated assaults, sexual assaults, mass shootings or acts of terror. Infectious disease exposure or witnessing violence are covered incidents while working.

What's Included

Trauma Counseling

Measurement-based therapy with a master's-level or higher therapist trained in post-traumatic incident mental health.

Lost Wage Benefit

100% of the insured individual's income from all employment sources while they're unable to work.

Recuperation Benefit

Reimbursement for out-of-pocket medical, dental, vision, hearing, and pharmaceutical expenses plus family caregiving wage support.

Student Financial Assistance Benefit

For insured students (or their legal guardians), receive \$100 per day until either the benefit cap is reached or the student returns to school.

Accidental Death Benefit

In the event of a death due to a covered incident, the insured's beneficiaries will receive their policy maximum.

Family Plan Added-benefit: Family coverage includes the insured; spouse (if applicable); and dependent, unmarried children to age 19 (26 if full-time students). This includes the relationship created by a domestic partnership. Newborn children are automatically insured from the moment of birth. A dependent child must be under the age of 19 at the time of application to be eligible for coverage. In addition, the Family Plan provides families of traumatized students with \$100 in financial assistance per day while the student is unable to attend school due to a trauma.

Underwriting is guaranteed issue; no age limitations for coverage; approved in and limited to the 50 United States; coverage is underwritten by Lloyd's of London.
